Disclosure Regarding Operational Update Report & Forward-Looking Statements

The number of rigs available for service is determined by calculating the number of days each rig was in our fleet and was under contract or available for contract. For example, a rig under contract or available for contract for six months of a year is 0.5 rigs available for service during such year.

Rig utilization rates are based on a weighted average basis assuming 365 days availability for all rigs available for service. Rigs acquired or disposed of are treated as added to or removed from the rig fleet as of the date of acquisition or disposal. Rigs that are in operation or fully or partially staffed and on a revenue-producing standby status are considered to be utilized. Rigs under contract that generate revenues during moves between locations or during mobilization or demobilization are also considered to be utilized.

Our method of computation of rigs available for service and rig utilization may not be comparable to other similarly titled measures of other companies.

The Tubular Goods Utilization Index represents the proportion of tubular goods (drill pipe and related products) that were on rental compared to the total inventory of tubular goods, and indexed to a base level of tubular goods inventory on rental during the 2005 – 2006 period. The Rental Tools Inventory represents the gross value of rental tools available for rental. Tubular goods rentals do not account for all the Rental Tools segment's revenues.

The Company cautions that numerous factors in addition to rental tools utilization and rental tools inventory can impact the Company's operating results and that a particular trend in utilization and inventory may or may not indicate a trend in or be indicative of the Company's financial performance.
