On March 22, 2016, the Reporting Issuer's Board of Directors declared stock dividend, payable to shareholders of record as of April 4, 2016 and issued on April 15, 2016.

The stock dividend equates to an annualized distribution rate of 1% or .01 of a share for each share held.


