Item 8.01 Other Events.

On May 17, 2019, the Texas Department of Insurance approved a rate increase for Maison Insurance Company, which is a wholly-owned subsidiary of 1347 Property Insurance Holdings, Inc. The rate increase is for the homeowners' line of business in Texas and is in the amount of 30.5% statewide. The rates are effective June 1, 2019, for new business, and August 1, 2019, for renewal business. The Company remains closed for new business in many of the counties which have the highest rate increases.
