TO THE INVESTMENT COMMUNITY:¹

On March 31, 2018, FirstEnergy Solutions (FES), all of its subsidiaries, and FirstEnergy Nuclear Operating Company (FENOC) announced that, in order to facilitate an orderly financial restructuring, they filed voluntary petitions under Chapter 11 of the United States Bankruptcy Code with the U.S. Bankruptcy Court in the Northern District of Ohio in Akron.

FirstEnergy Corp. (FE) and FE's other subsidiaries, including all regulated subsidiaries, are not part of the filing and will not be subject to the Chapter 11 process. Allegheny Energy Supply (AE Supply), which owns the Pleasants Power Station, also is not part of the filing. AE Supply is pursuing options to sell the Pleasants plant, consistent with FE's exit from competitive generation.

As you know, a Restructuring Working Group (RWG) was formed in January 2018 to advise FE management regarding a constructive restructuring of FES if a bankruptcy filing occurred. The RWG has been engaged in substantive negotiations with a steering committee of FES noteholders representing a majority of FES debt outstanding (not including Bruce Mansfield Sale Leaseback related debt) regarding a potential comprehensive resolution through a constructive settlement. Discussions are expected to continue over the next several weeks. The parties have also joined an agreement filed with the Bankruptcy Court for approval to advance an efficient discovery and settlement process.

As of March 31, 2018, FES, all of its subsidiaries, and FENOC will be deconsolidated from FE's financial statements.


